#### **CONDITIONS FOR RECREATIONAL VEHICLE PARKING PERMIT**

**Annual:** The recreational vehicle may park overnight on a public street in front of or adjacent to the location indicated on the permit for a 48-hour periods to allow for preparation and unloading of the vehicle. Multiple 48-hour preparation and unloading periods may be allowed throughout the permit term but these periods shall be nonconsecutive.

**Guest:** The recreational vehicle of a guest of an Encinitas resident may park on the public street in front of or adjacent to the residence location identified in the permit for a period not to exceed seven (7) consecutive days. A maximum of three (3) guest permits can be issued in a twelve (12) month period.

**Personal Hardship:** The recreational vehicle is subject to conditions as specified on the permit.

**Professional Hardship:** The recreational vehicle may be parked overnight on the public street in front of or adjacent to the business location indicated on the permit while the vehicle is being repaired or serviced at the specified business location. The vehicle shall be removed from the public street as soon as possible once the repairs or service is complete.

**Lodging:** The recreational vehicle shall not be used for overnight camping, lodging, sleeping, residing or accommodation purposes.

I hereby certify under penalty of perjury that the statements made in this application are true and correct to the best of my knowledge. I understand any false statements or information are grounds for denial of this application or revocation of the permit. I acknowledge I will adhere to the conditions as stated on the permit.

It is the responsibility of the applicant to contact the office before the permit expires. The City does not send out renewal notices for Recreational Vehicle permits.
